We are in receipt of your letter of October 31, 2001. In your letter you requested our approval to consolidate the King and Tabor Gas Gathering Systems by connecting the seven wells in the King Gas Gathering System to Dugan's Tabor Gas Gathering system.

In addition to consolidating the King and Tabor Gas Gathering systems, you also requested approval for the off-lease measurement and sale of natural gas produced from Dugan's Com No. 91 well, to the sales meter located at the Com IE CDP sales meter.

It is our understanding that there will be no change in operations for wells on either system, and the allocation procedures currently approved for both systems are identical and will continue to be used for the consolidated system.


