RE: Application to add wells to PLC – 108 (Jicarilla “A” Ridge)

Gentlemen:

Conoco is filing an application to add ten (10) wells to the above mentioned PLC which was originally submitted by Merit Energy Company. Conoco purchased these leases from Merit on October 1, 1995. Working interest, net revenue and over-riding royalty interests are identical in all of the subject wells. These interests are identical for all producing horizons.

The following items are submitted in support of this application:

1. Exhibit A is a list of the wells already included on the PLC and a list of wells to be added.
2. Exhibit B is a plat of the affected leases with the subject wells identified.
3. Exhibit C contains production volume reports of wells to be added.
4. Exhibit D contains gas analysis reports of wells to be added, analysis of gas retrieved at the Jicarilla “A” Ridge CPD, and analysis of the Jicarilla “A” 22Y (offset to Jicarilla “A” 22C).
5. Exhibit E is a schematic of the Central Facility along with plats showing the location of the facility.

Two of the ten wells in this application, Jicarilla “A” No. 15B and Jicarilla “A” No. 22C, are proposed Jicarilla A lease Mesaverde/Dakota drills (see Exhibit A for detail). Scheduled for spud in April 2002, the proposed Jicarilla “A” No. 22C D&E will require approval of this ammended PLC in order to put the well into sales.


