A study has been made to revise the battery and commingle the production from all accounts from the W. P. Byrd and W. P. Byrd "A" leases. These leases are located in Section 12, T20S, R36E in Lea County, New Mexico.

There are presently two wells producing from each account. All wells to be commingled are producing from the Grayburg-San Andres formation. A map and schematic of the proposed system is attached. All royalty and working interest owners have been notified by certified mail. Copies of the letters and receipts of mailing are attached.

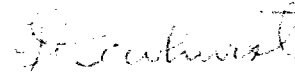

Increase in income using December, 1971, production calculates \$48 per month. If the crudes are commingled, storage time and exposed surface area will be less to prevent excess evaporation. The decrease in weathering will increase the volume as well as the gravity. Positive displacement meters with accessories to meet requirements set forth in the NMOCC Manual for the Installation and Operation of Commingling Facilities will be installed.

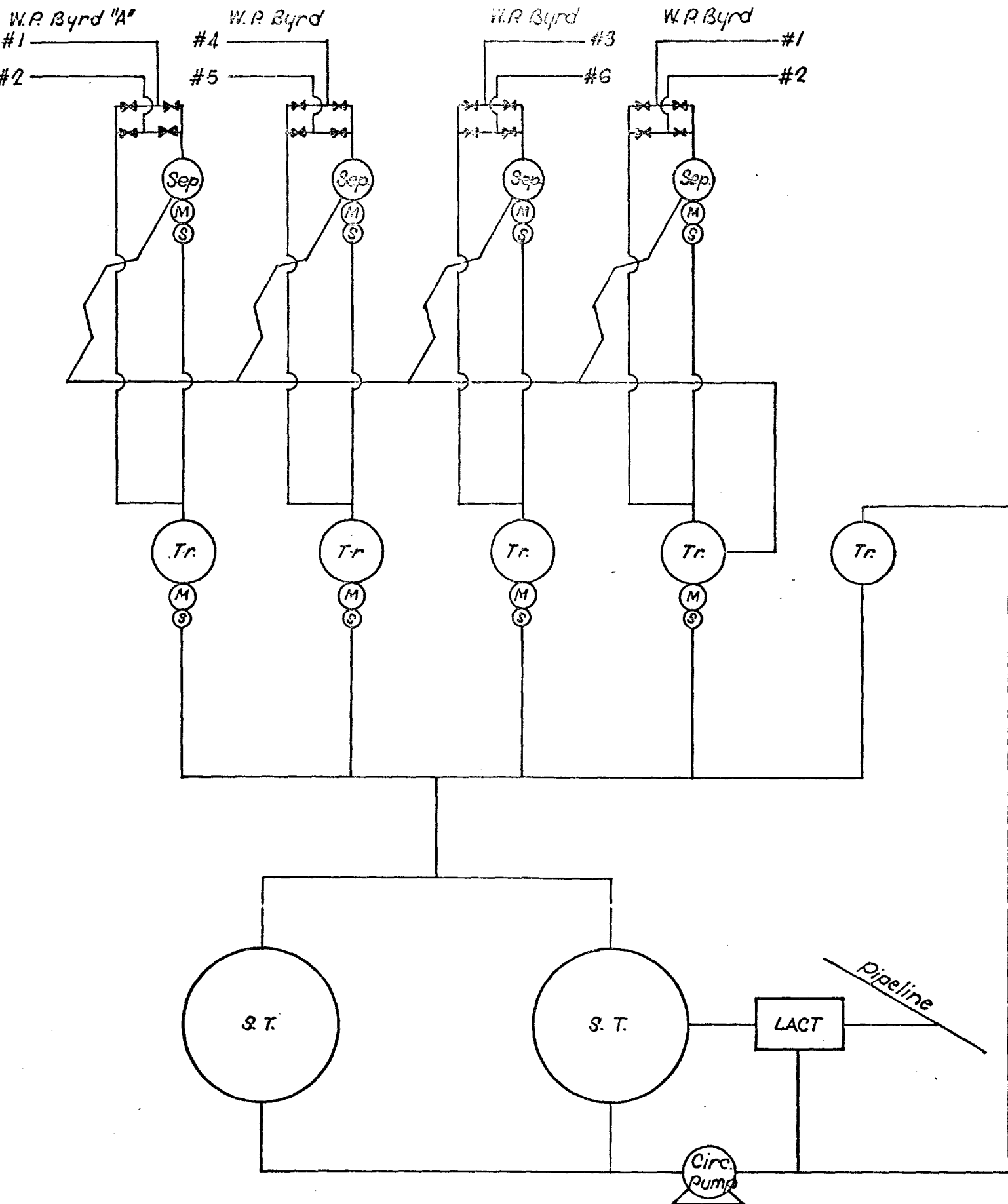

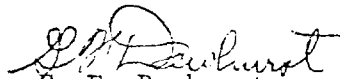
