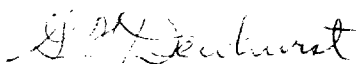

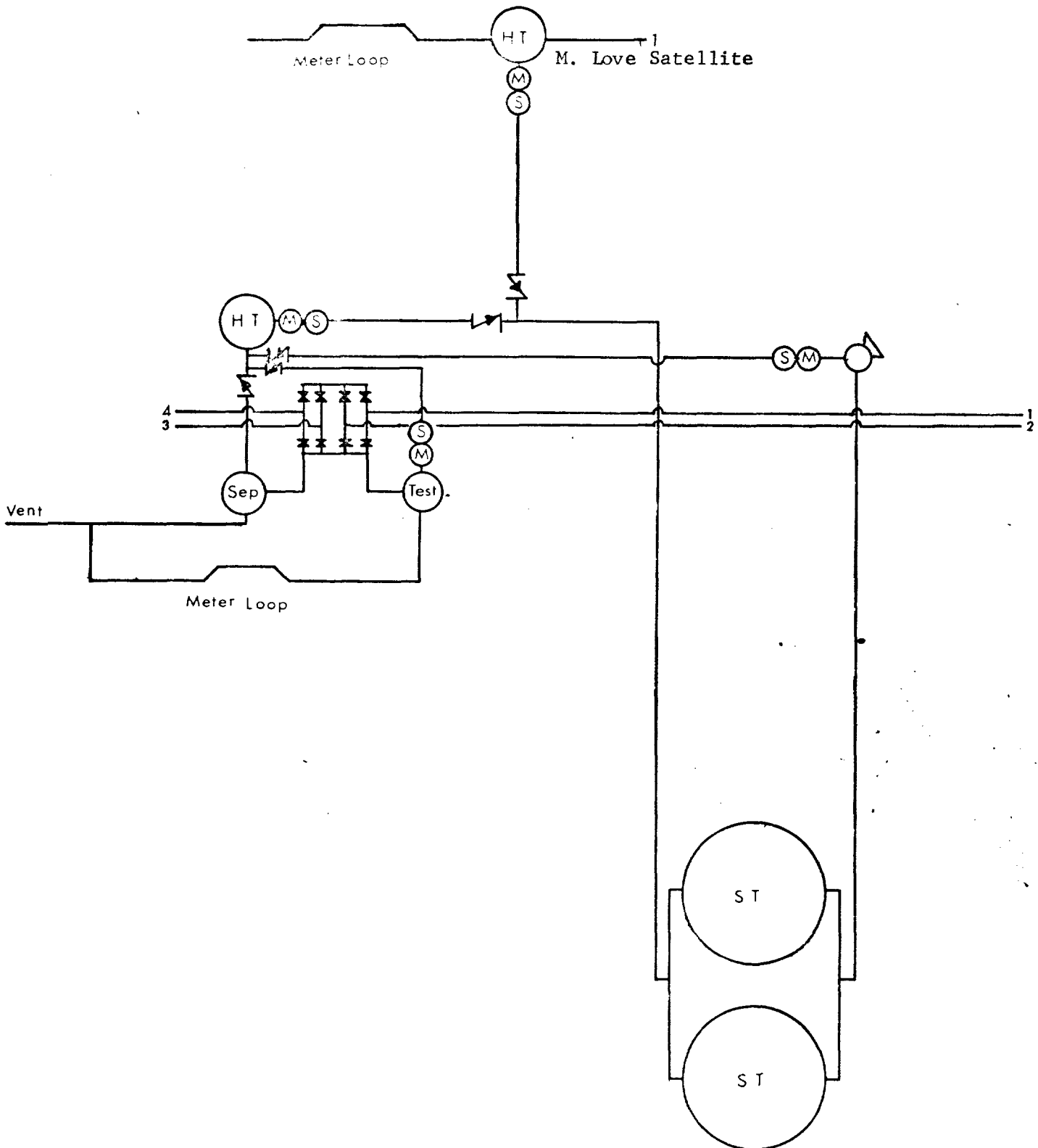

PROPOSED BATTERY

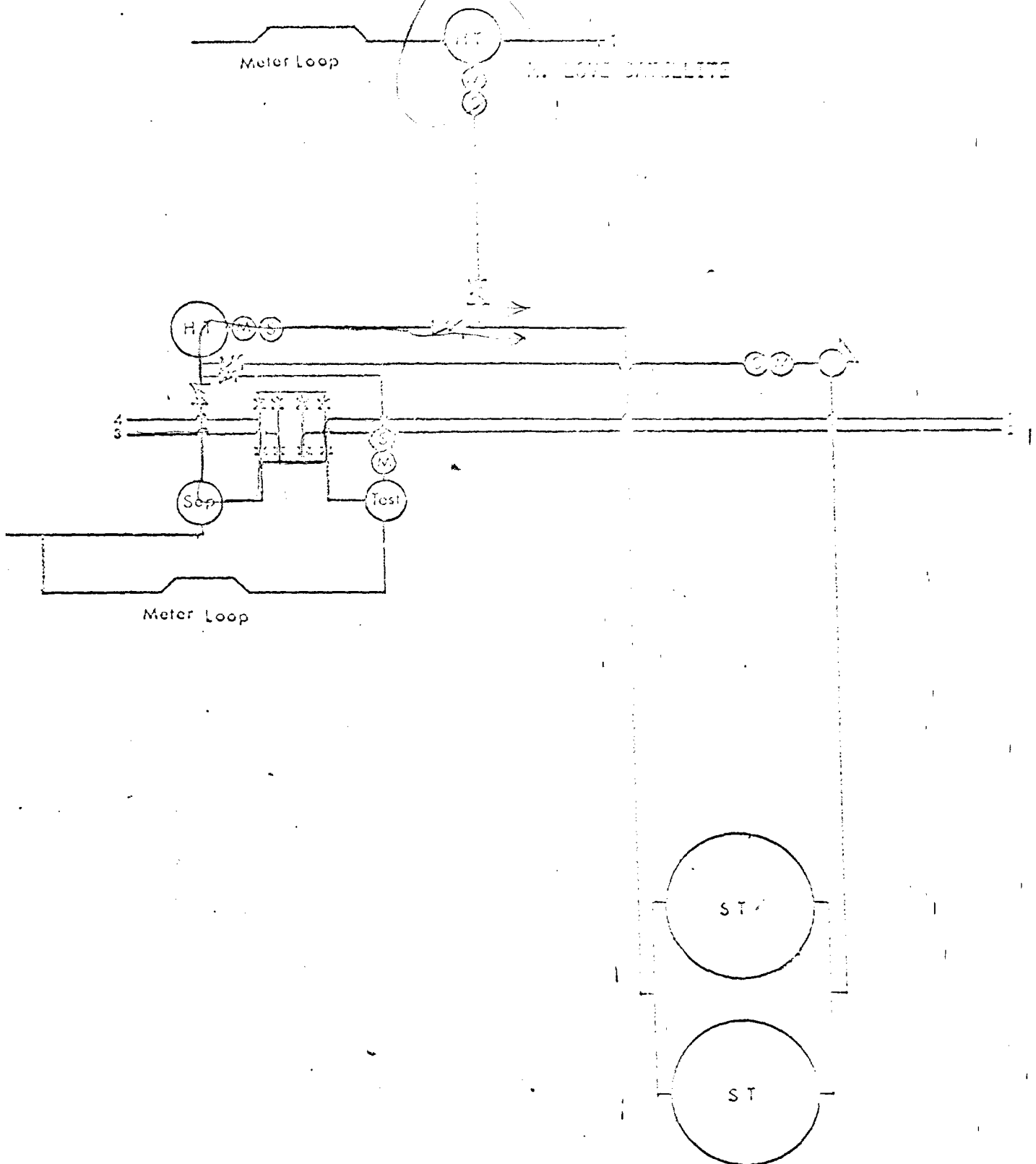


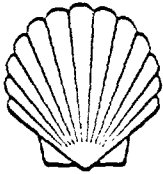
