

Gentlemen:

Mobil Oil Corporation respectfully requests permission to commingle North Vacuum Abo production from the State "MM" Lease (S/2 SE/4 Sec.7, T17S, R35E) with like production from the State "A" Com. Lease (E/2 SW/4 Sec.7, T17S, R35E).

Both subject leases in this application have common lease ownership, working interest ownership, royalty ownership, and ORR ownership. The production of all wells in this application are of marginal nature; therefore, we request permission to allocate production to each well by quarterly well tests.

2. Exhibit 2 - Schematic of the proposed State "A" Com. commingled tank battery
3. Exhibit 3 - Letter from purchaser of crude, consenting to the proposed commingling


