Gentlemen:

Your letter of December 16, 1971 requests approval for off-lease storage for lease SF 079395. As stated in your letter, production from former East Bisti Unit well No. 77, located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  sec. 34, T. 25 N., R. 10 W., San Juan County, New Mexico, lease SF 079395, is to be stored and sold from an existing tank battery installation located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$  sec. 34. This tank battery is located on Monsanto Oil Company lease NM 09032 and their approval to use this battery has been received by you. It is understood there will be no commingling of production and it would not be economical to provide on-lease storage. Your off-lease storage plans are hereby approved.

You are advised that a surface use permit should be obtained from the Bureau of Land Management, Santa Fe, for that land utilized for the tankage, inasmuch as the status of lease NM 09032 is of an indefinite nature. Approval by the New Mexico Oil Conservation is also required.


Gentlemen:
