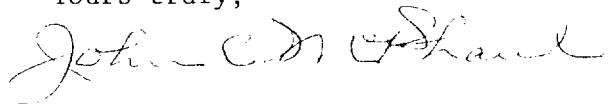

We hereby apply for an exception to Rule 309-A to permit us to commingle the production from our Gissler "A" #12 (LC 029338), now being completed, with the production from our Gissler #1 (NM 2746). All production is from the same common source of supply (Square Lake) and all ownership of the two wells, including working interest ownership, royalty interest ownership and overriding interest ownership is identical. Adequate facilities (Porta-Chek well tester) will be provided to determine production from each well. All parties have been notified by certified mail of our intent to commingle production from these two leases.

Supporting information is attached. If further information is needed, please let us know.

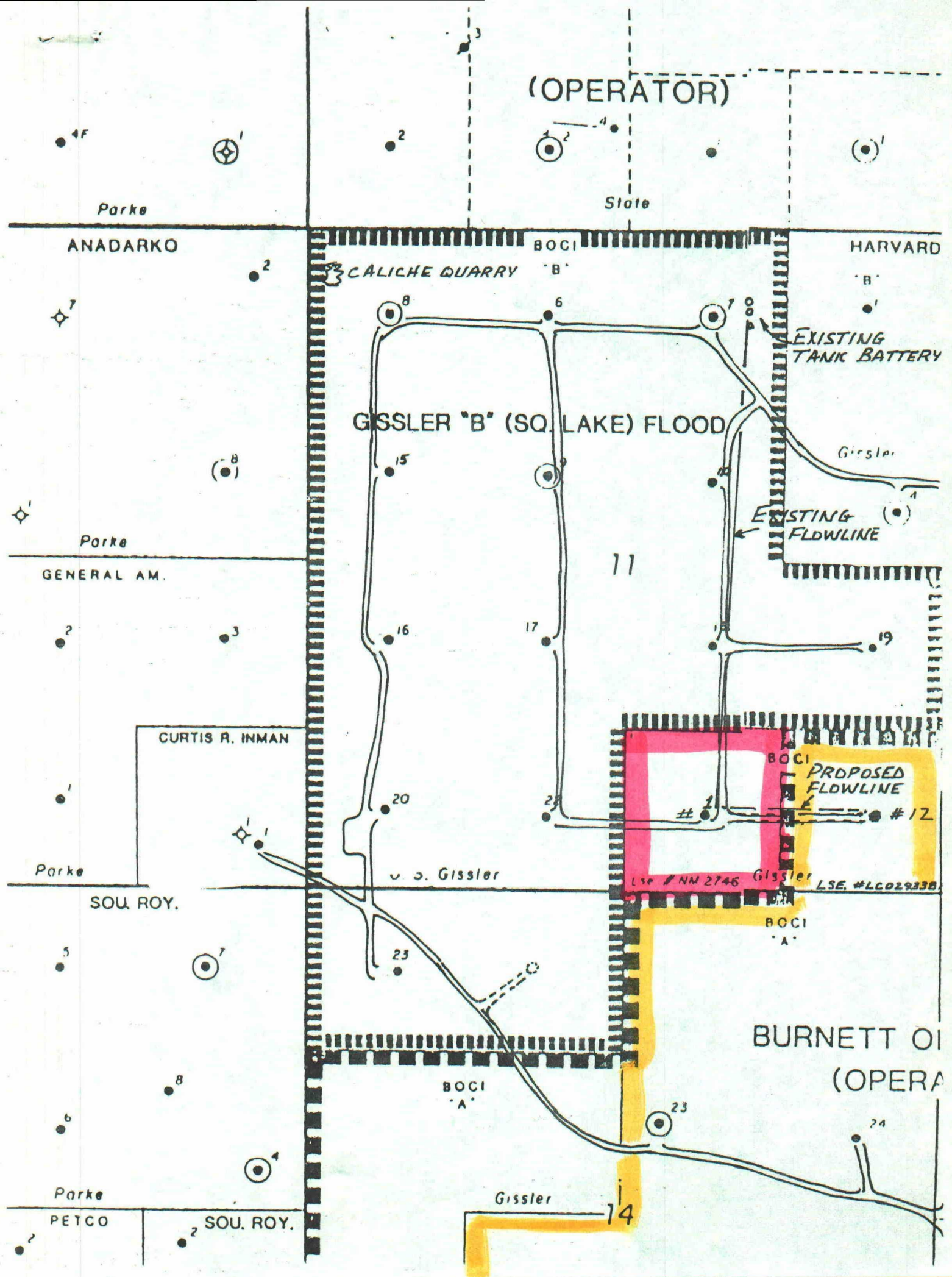
