As an exception to the requirements of Rule 309-A of the Division Rules and Regulations, and pursuant to the provisions of Rule 309-C, the above-named company is hereby authorized off-lease storage for Pecos Slope-Abo gas pool production from the following lease:

Lease Name: Charlotte Federal Well No. 2  
Description: Unit M, Sec. 17, T-7-S, R-26-E, Chaves County

The aforesaid production is to be transported prior to measurement to its own tank battery to be located in Unit P, Section 18, Township 17 South, Range 26 East on the D. J. Leeman Lease.

NOTE: This installation shall be operated in accordance with the provisions of Rules 309-A and 309-B of the Division Rules and Regulations, and there shall be no intercommunication of the handling, separating, treating, or storage facilities designated to each of the above leases.


REMARKS: This off-lease storage permit will allow production facilities for the subject well to be moved outside the Pecos River Flood Plain.

Application is hereby made for administrative approval under Rule 309-C for off-lease storage for subject well.

The Bureau of Land Management has issued Special Stipulations that the production facilities for subject well be located outside of the Flood Plain of the Pecos River as illustrated by Exhibit I, a plat showing the location of the well, the proposed production pad ("PP") and the Flood plain boundaries. Exhibit II is the survey plat giving the exact location and dimensions of the production pad. Exhibit III is a copy of the special stipulations as provided by the Mineral's Management Service. Exhibit IV is a Land Plat showing the two Federal Leases affected by this request. Only production from the subject well will be handled thru this production pad.


