Exxon Corporation requests permission to commingle condensate production from Eumont Gas Com. No. 3, Eumont Gas Pool, LC 048741(A), LC 948741(B) comprising the NE/4 of Section 35, T-20-S, R-36-E and L. C. Fopeano Federal AC 2, Eumont Oil Pool, LC 048741(B), comprising all the NE/4 except the NE/4 of the NE/4, Section 35, T-20-S, R-36-E, Lea County, New Mexico.

L. C. Fopeano Federal A/C 2, Well No. 7, located in Unit "G", Section 35, T-20-S, R-36-E was shut in May 1, 1972 due to a gas-oil-ratio of more than 100,000 to 1. On July 24, 1974, Exxon changed the name of L. C. Fopeano Federal A/C 2, Well No. 7 to Eumont Gas Com. No. 3, Well No. 2. NMOCC Order No. R-4851 of September 10, 1974, authorizes Exxon to simultaneously dedicate its non-standard 160-acre gas proration unit comprising the NE/4 of Section 35, T-20-S, R-36-E, Eumont Gas Pool, Lea County, New Mexico to its Eumont Gas Com. 3, Well Nos. 1 and 2, Units A and G respectively, with unit production to be taken from said wells in any proportion.

Gas from Eumont Gas Com. No. 3, Well No. 2, is taken from the casing and delivered to El Paso Natural Gas. This well pumps 5 to 6 bbls condensate per day to Tank Battery No. 2, Unit "G", Section 35, T-20-S, R-36-E, where it is commingled with the following wells:

L. C. Fopeano Federal A/C 2, Well No. 2, Eumont Oil, Shut-In  
L. C. Fopeano Federal A/C 2, Well No. 8, Eumont Oil, Allowable 6 bbl.

The gravity of the condensate from Eumont Gas Com. No. 3, Well No. 2 and the gravity from oil run from Battery No. 2, Unit "G", Section 35, T-20-S, R-36-E, averages 34.1 API. Both oil and condensate are classed as sour, allocation of production will be based on well tests.




