Re: Request for an off lease storage permit on the S. E. Anderson lease located in Unit B, Sec. 30, T-9-S, R-35-E, Lea County, New Mexico.

Dear Sir:

Amerada Petroleum Corporation requests permission to store on the S. E. Anderson Lease condensate produced from the S. E. Anderson "A" No. 1 located in Unit P, Sec. 19, T-9-S, R-35-E, Lea County, New Mexico.

The tanks that are planned to be used were previously used for the S. E. Anderson No. 1, Devonian, which is now temporarily abandoned. The other tanks on the S. E. Anderson are used for Bough C oil storage. There will be no commingling involved.

Magnolia Pipeline Company is the purchaser of the condensate and oil and is presently connected to the tanks involved. Since these tanks are already in place and connected, off lease storage would result in considerable savings to both Amerada and Magnolia Pipeline Company.

Condensate from the Anderson "A" Lease is presently being stored on the Anderson lease by temporary permission granted by Mr. J. D. Ramey. Since this temporary permission expires June 1, 1965, Amerada requests permission to continue off lease storage for the life of the Anderson "A" lease.
