
Gentlemen:

Coastal States Gas Producing Company is requesting administrative approval for off-lease storage in that we be permitted to have off-lease storage for our McGuffin Lease located in NW/4 of Section 29, T-9-S, R-33-E, Lea County, New Mexico, in the Flying "M" (San Andres) Field. Temporary storage was constructed pending outcome of the Unit being formed in the Flying "M" Field. The McGuffin was not included in the final Unit and we are requesting permission to produce this lease in a surplus battery that was in use prior to the unitization of the Flying "M" Field.

Coastal States is requesting that we be allowed to transport production prior to measurement from one lease to another lease for storage. The storage facilities for this lease will be located as shown on the attached plat. There will be no intercommunication of the handling, separating, treating, or storage facilities between this lease and the lease the tanks will be located on. There will be no commingling of production between leases. This request is made for convenience of pipeline and in order to consolidate batteries to utilize future LACT installation.

As requested in Rule 309-C, Part 5, attached is a list of parties owning an interest in this lease. They were notified by registered mail or certified mail on May 23, 1967, of our intent to request off-lease storage. Attached are copies of the receipts of our notification.
