Reference is made to your application dated March 19, 1968, for an exception to Rule 309-A of the Commission Rules and Regulations to permit off-lease storage for your Roy Epperson "A" Lease which comprises the N/2 SE/4 of Section 23, Township 11 South, Range 33 East, Inbe Permo-Pennsylvanian Pool, Lea County, New Mexico. It is our understanding that the tank battery for this lease would be in Unit P of Section 23 on your Roy Epperson Lease.

Pursuant to the authority granted me by Rule 309-C of the Commission Rules and Regulations, Midwest Oil Corporation is hereby authorized off-lease storage as described above, provided that there shall be no intercommunication of the handling, separating, treating, or storage facilities designated to each lease.

Your application for off-lease storage for your State "O" Lease in Section 26 immediately south of the Epperson Lease is still being held pending receipt of filing fees by the State Land Office and approval of the off-lease storage by them.




