Dear Sir:

Under a commingling agreement, Amerada has been moving oil from its #1 Rose Eaves "A", location shown above, to tank batteries located beside the Amerada #1 Rose Eaves, SE SW, Section 35, 16S-38E. The Eaves well in Section 35 is now depleted and the well is plugged and abandoned. The location and pad have been cleared for inspection, except for the tank battery, and we are continuing to store our oil from the Rose Eaves "A" in these tanks.

I have just found out that we should have authorization for off lease storage, and therefore we now respectfully request that we be allowed to continue off lease storage. We feel that presently producing well will not produce for a long period of time and we should avoid the additional expense of attempting to move the old tanks.

I am enclosing three copies of plats showing the present situation. If you need other information, please advise.
