ANADARKO PRODUCTION COMPANY AS OPERATOR OF THE H. J. LOE FEDERAL LEASE, LOCATED IN THE SE/4 SW/4 SECTION 31-T16S-R31E, EDDY COUNTY, NEW MEXICO, REQUESTS ADMINISTRATIVE APPROVAL FOR OFF-LEASE STORAGE AS SPECIFIED UNDER RULE 309C. THE TANK BATTERY (CONSISTING OF TWO-210 BARREL TANKS) IS TO BE LOCATED IN UNIT "F" (SEE PLAT ATTACHED).

THE LOCATION MENTIONED ABOVE WAS SELECTED BECAUSE OF ITS PROXIMITY TO A WATER PLANT WHICH WILL COLLECT AND RE-INJECT PRODUCED WATER. OIL PRODUCTION COLLECTED WILL NOT BE COMMINGLED WITH ANOTHER LEASE PRIOR TO PIPE LINE RUNS.

ANADARKO OWNS 100 PERCENT OF THE WORKING INTEREST AND HAS NOTIFIED UNITED STATES GEOLOGICAL SURVEY, WHO IS THE SOLE ROYALTY OWNER, OF OUR INTENTION TO REQUEST PERMISSION FOR OFF-LEASE STORAGE (SEE COPY OF LETTER ATTACHED).

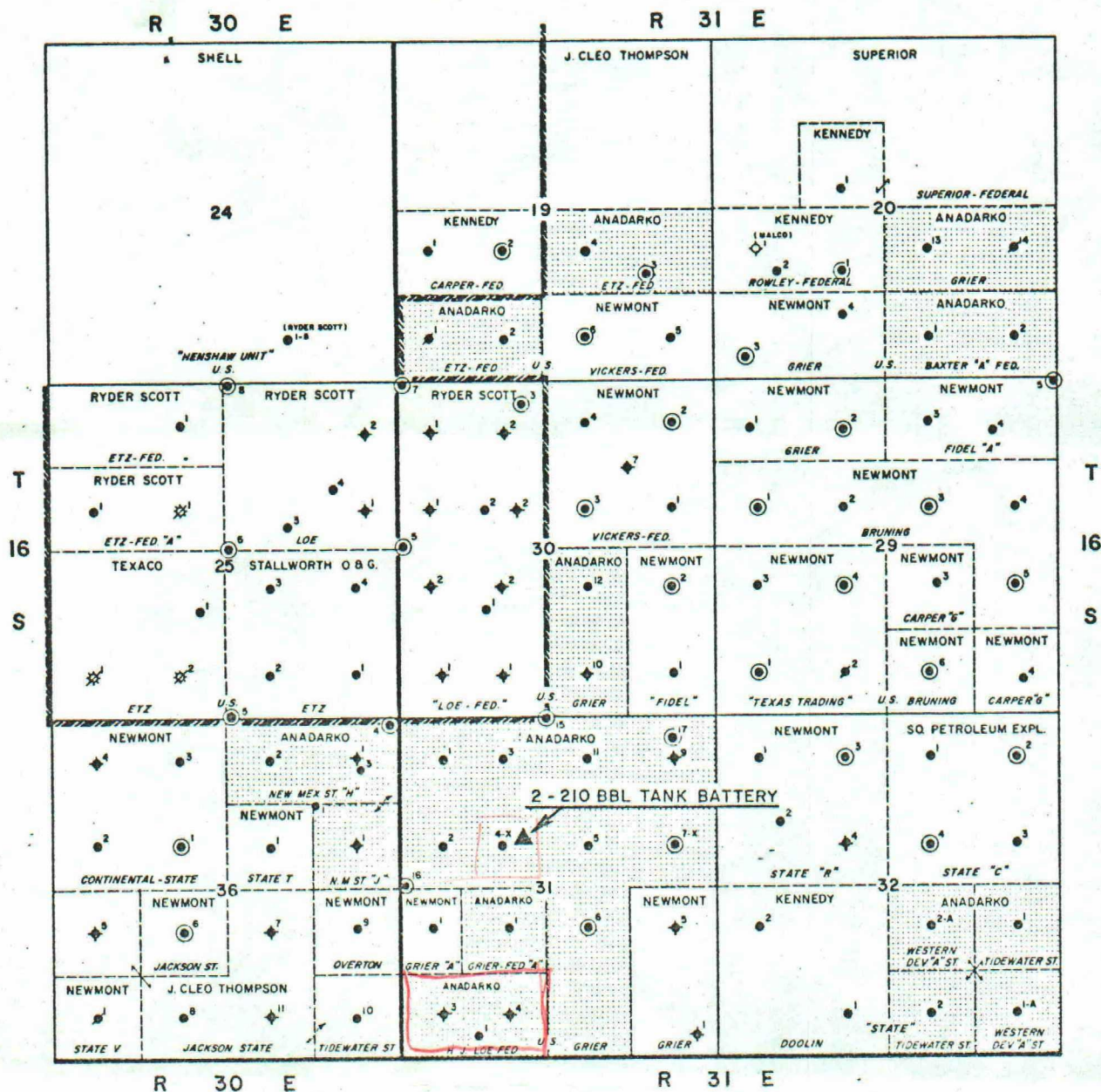

(Grayburg - San Andres Zone)

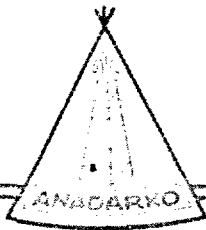

GENTLEMEN:

ANADARKO PRODUCTION COMPANY AS OPERATOR OF THE H. J. LOE FEDERAL LEASE, LOCATED IN THE SE/4 SW/4 SECTION 31-16S-31E, EDDY COUNTY, NEW MEXICO, IS MAKING APPLICATION TO THE NEW MEXICO OIL CONSERVATION COMMISSION FOR OFF-LEASE STORAGE WHICH CAN BE APPROVED UNDER STATEWIDE RULE 309-C, PROVIDED THAT CERTAIN REQUIREMENTS BE MET.

WE ARE ENCLOSING A PLAT INDICATING THE PROPOSED LOCATION OF THE TANK BATTERY WHICH IS NEAR A WATER PLANT THAT WILL COLLECT AND RE-INJECT PRODUCED WATER. BY LOCATING THE BATTERY IN THE IMMEDIATE AREA OF THE PLANT, A SAVING WILL BE REALIZED BY THE REDUCTION OF THE NUMBER OF FLOW LINES AND THE CENTRALIZING OF EQUIPMENT.
