Comes Jake L. Hamon, acting by and through the undersigned attorneys, and hereby makes application for administrative approval of off-lease storage of oil in connection with State No. 1 - K-4203 located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  Section 30, Township 16 South, Range 36 East, Lea County, and in support thereof respectfully shows:

1. That Jake L. Hamon is the operator of State No. 1 - K-4203 which has recently been completed in the East Shoe Bar - Devonian Pool in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  Section 30, Township 16 South, Range 36 East, Lea County.

2. Applicant is in the process of erecting a tank battery consisting of two 1,000 barrels tanks at the same location as applicant has another tank battery for the production of oil from wells 1, 2 and 3 on State Lease K-33. The location of the tank battery for State No. 1 - K-4203 will save considerable expense in connection with the pipeline for the disposition of production. The production from K-4203 will be handled entirely separately from the commingled production from Wells 1, 2 and 3 on State Lease K-33. See plat attached.

Gentlemen:

Jake L. Hamon as operator of the State K-33 Lease in Section 30, T-16-S, R-36-E, Lea County, New Mexico, proposes to commingle production from the State K-33 No. 1 and No. 2 wells, which Union Oil Company of California owns a 6.250 % overriding royalty, with the State K-33 No. 3 well which Union Oil Company of California owns a 3.125% overriding royalty.

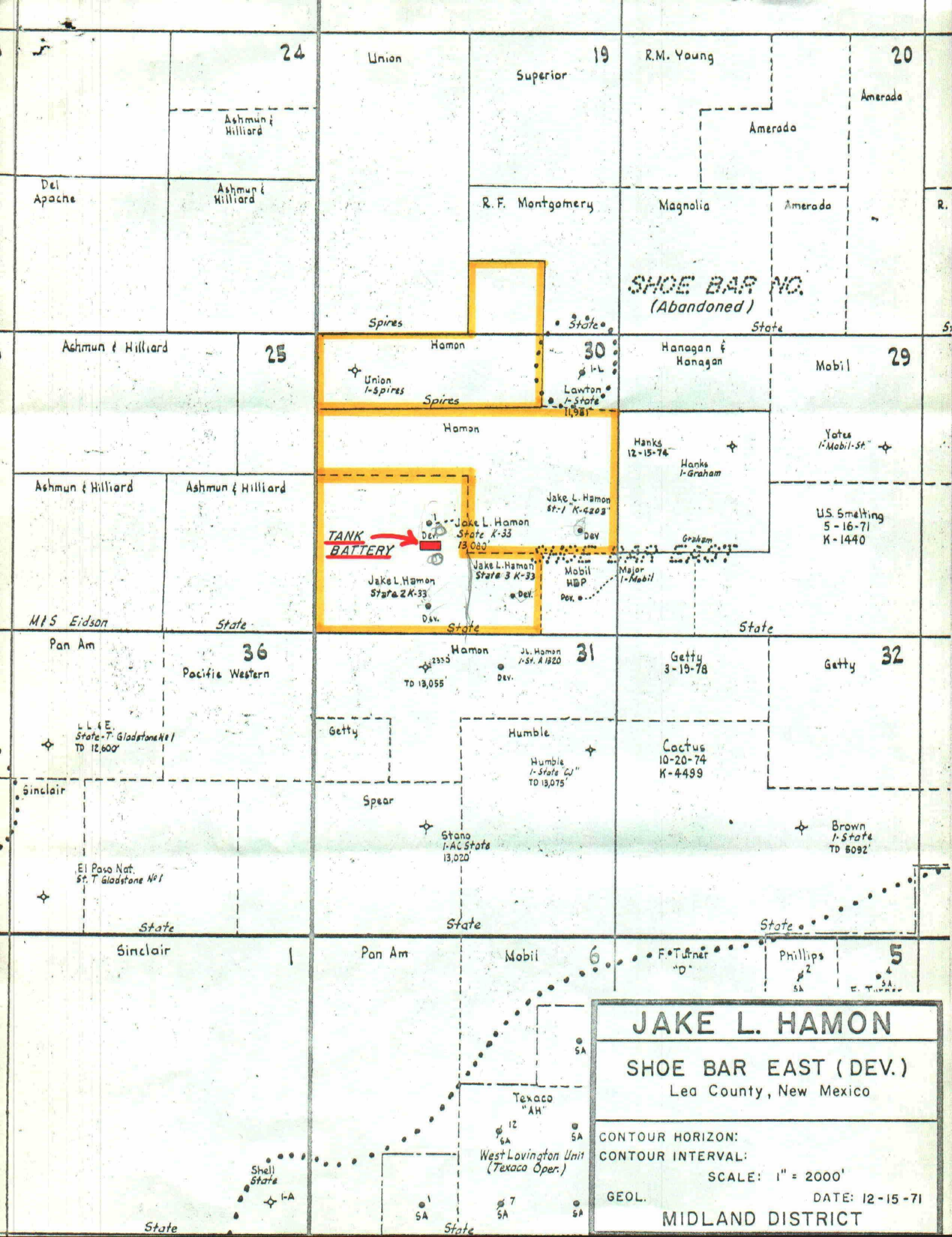
The oil production from the State K-33 No. 3 well is to be metered by a one barrel volume dump type metering separator and test lines are to be provided for testing and proving the metering equipment.

As an overriding royalty owner in the K-33 Lease, I have no objection to this metering system.

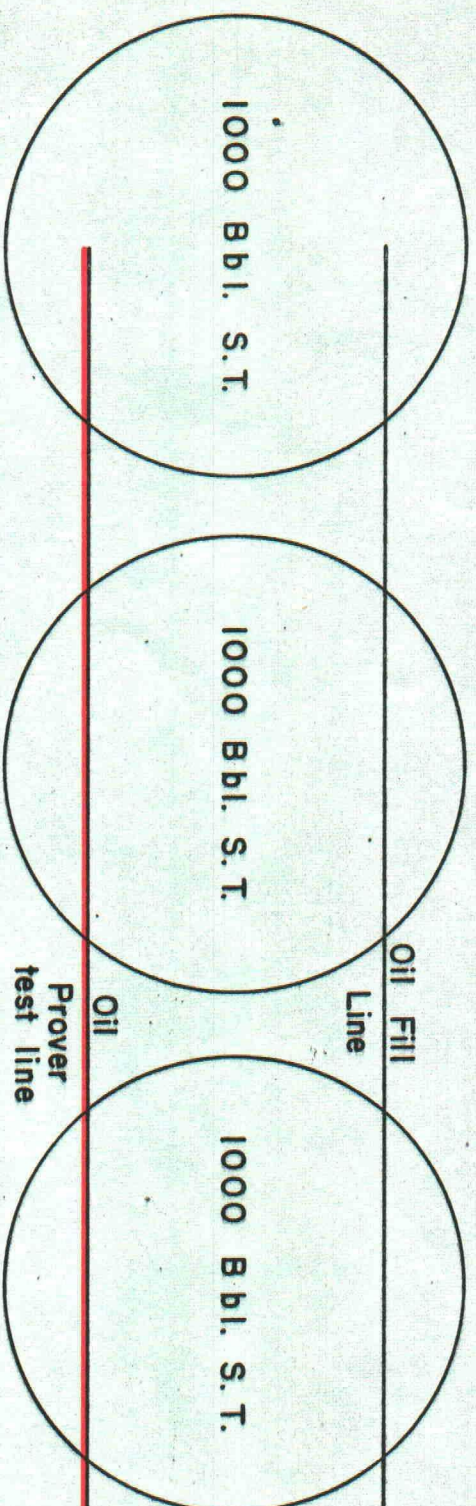

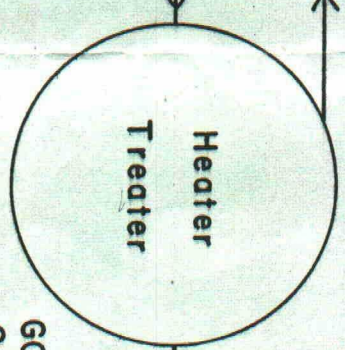




State K-33 No. 1
