Description: NE/4 NE/4 Sec. 23, T-17-S, R-25-E, Eddy County


The aforesaid production is to be transported prior to measurement to its own tank battery to be located in

Dear Mr. Ramey,

Under the provisions of OCC Rule 309C, Yates Petroleum Corporation seeks Administrative Approval for an exception to OCC Rule 309A whereby production from our Johnson FE Lease may be transported by pipeline prior to measurement to a tank battery to be located on the Winters DN Lease located in Unit P, Section 14-T17S-R25E. The Johnson FE Lease is in Unit A, Section 23-T17S-R25E and is in the main water course of Eagle Draw.

The following requisites for off-lease storage are met:

1. Both leases produce from the same common source (San Andres);
2. Commingling of production from the two leases will not result;
3. There will be no intercommunication of the handling, separating, treating, or storage facilities designated to each lease;
4. Yates Petroleum is the sole working interest owner in both leases and waives objection to the off-lease storage;
5. A topography plat and an ownership plat are attached.

It is proposed to build the Johnson FE battery adjacent to the Winters DN battery which would be more accessible and less susceptible




