Description: NE/4 SW/4 Section 13, Township 18 South, Range 27 East, Eddy County


The aforesaid production is to be transported prior to measurement to its own tank battery to be located in


Unit Letter P Section 14 Township 18 South Range 27 East

One attached plat shows the requested location of the Shaw Federal No. 1 tank battery which is presently located at:

Shaw Federal Well No. 1
LC - 061572
K - 2310' FSL & 1650' FWL
Section 13, T 18S, R 27E
Eddy County, New Mexico


We request permission to relocate this tank battery at 1,000' FSL & 450' FEL Section 14, T 18S, R 27E, Eddy County, New Mexico.

This will permit us to utilize the existing caliche pad, electrical outlets and salt water disposal facilities at our Artesia State Unit Water Plant. Presently the Shaw Federal #1 has only a single 210 bbl. storage tank and a salt water disposal pit. It is operating without the benefit of a heater-treater, circulating pump or a caliche pad. Rather than make these improvements at the present location I would much prefer to relocate this single well tank battery as part of an impending improvement program.

A second plat shows the existing Artesia State Unit facilities in black and the requested Shaw Federal #1 facilities in red. The Shaw Federal tank battery is to consist of two 210 bbl. storage tanks, 4' x 20' gun barrel, circulating pump and piping necessary to circulate tank bottoms and dispose of produced water.


It will be necessary to lay a 2" line from the Shaw Federal #1 to the Water Plant for one of two reasons: (1) dispose of produced water in the event the battery is not moved or (2) a flow line from the well to the relocated tank battery.




1000' FSL, 450' FEL
