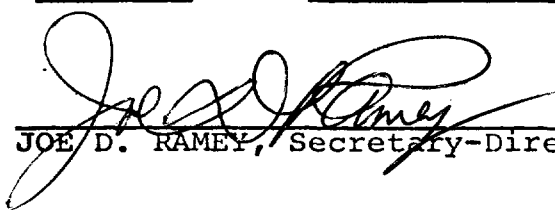
The aforesaid production is to be transported prior to measurement to its own tank battery to be located in

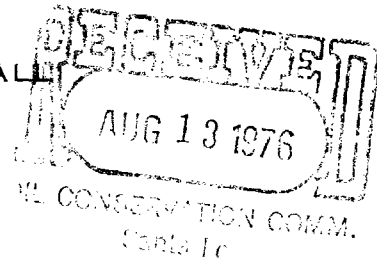

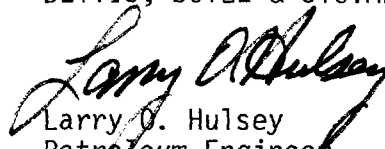
