Gentlemen:

This is Amerada's application for administrative approval, as an exception to Rule 303(a), to commingle the Grayburg oil with the McKee condensate produced from applicant's J. R. Phillips lease in the NE $\frac{1}{4}$ of Section 1-20S-36E, Lea County, New Mexico.

Applicant shows,

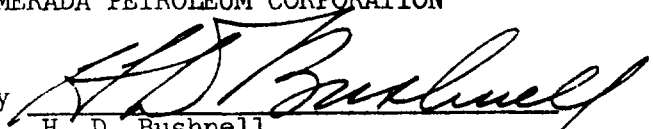
- (a) The four Grayburg wells during April of this year produced a total of 4,013 barrels of oil having a gravity of 32 degrees (A.P.I.) and a market value of \$2.71 per barrel;
- (b) The single McKee well during April produced 269 barrels of condensate having a gravity of 67 degrees (A.P.I.) and a market value of \$2.73 per barrel;
- (c) The commingled product will have a calculated gravity of 38.2 degrees (A.P.I.) with a value of \$2.89 per barrel.

A schematic diagram of the proposed installation and a plat showing the location of all wells on the J. R. Phillips lease and the pool from which each well is producing is attached and made a part of this application.

A copy of this application has been mailed by registered mail to all persons owning any interest of record in the acreage, which interest appears in the applicant's files, and a list of the names and addresses of such owners is attached to the original copy of this application.

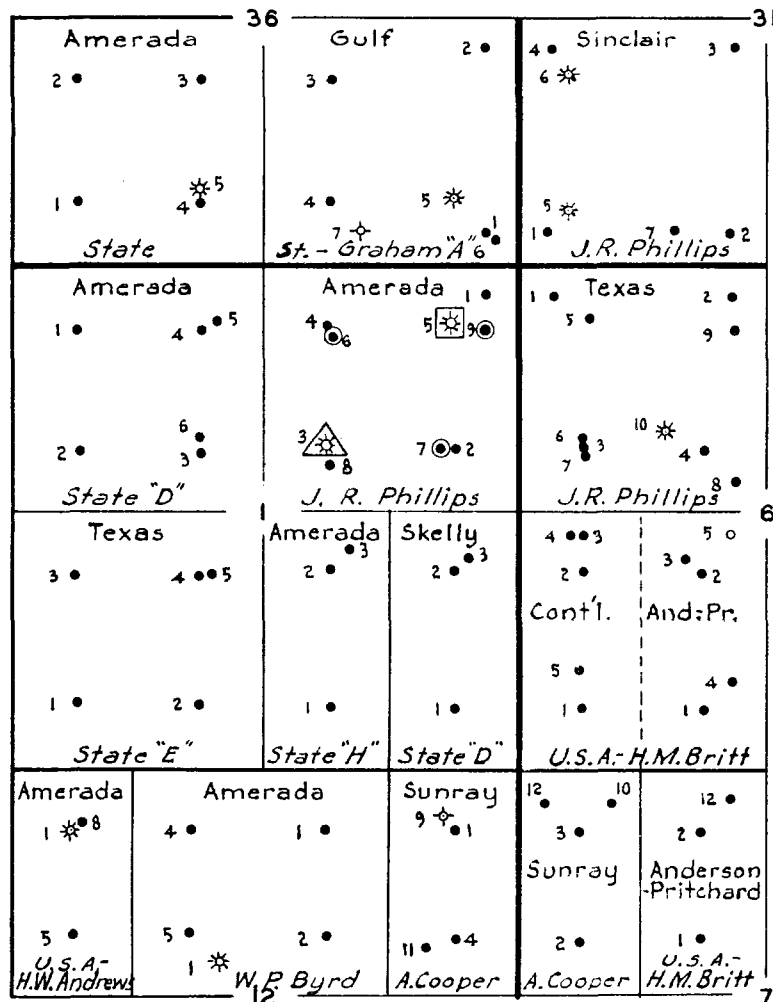

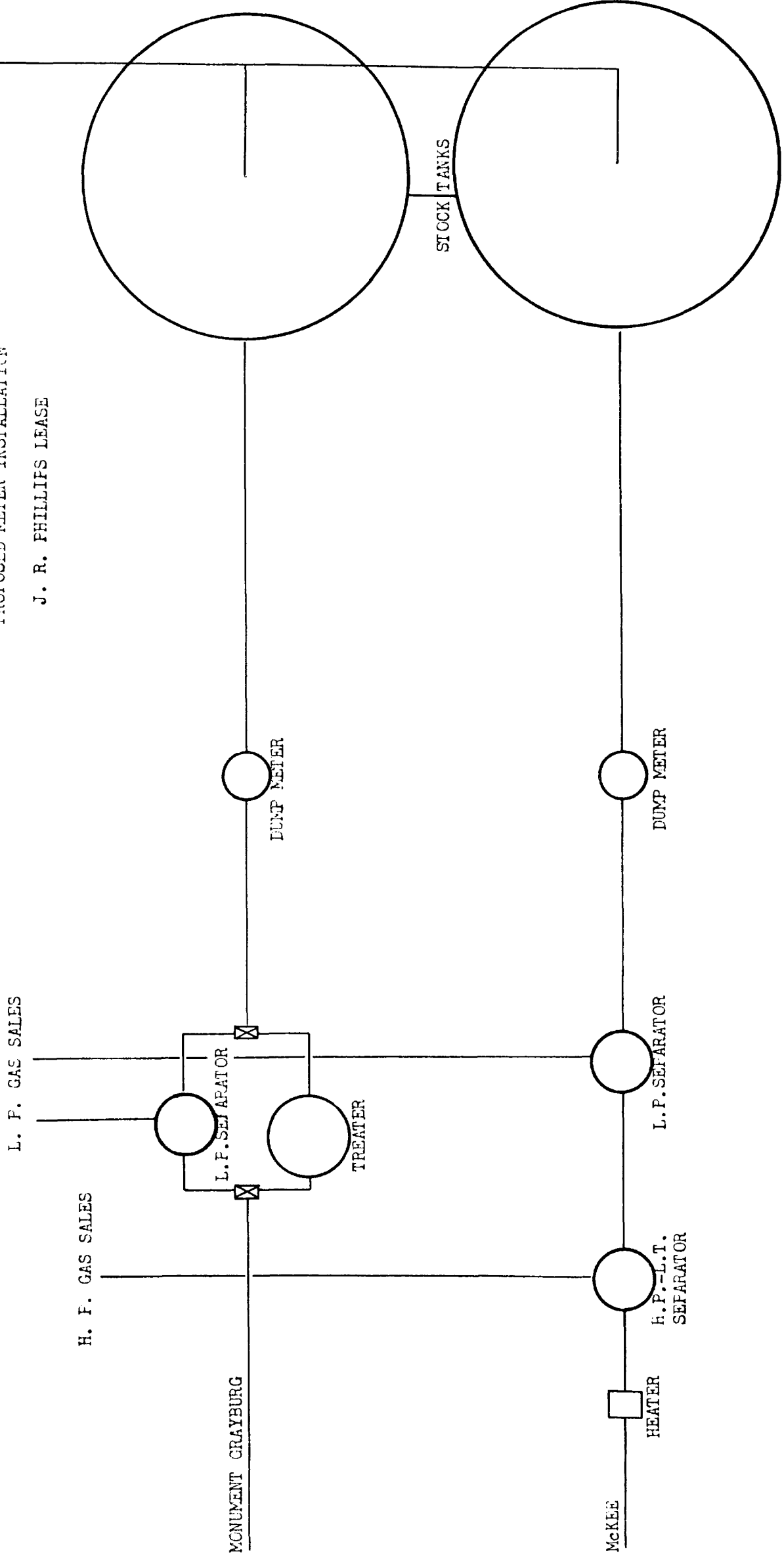

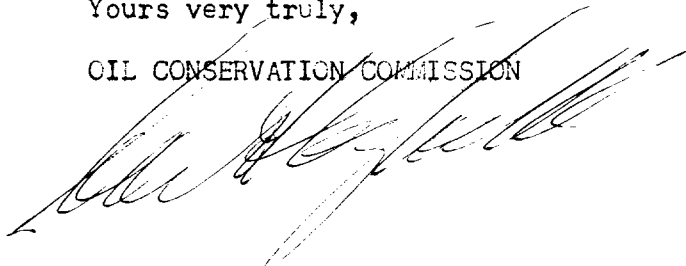
