Gentlemen:

Continental Oil Company respectfully requests administrative approval
under the provisions of statewide Rule 303 (b) as set forth in Order No. R-1597
for commingling production after separate measurement from the Monument, Weir,
and Weir-Tubb Gas Pools on its Britt B-15 Lease comprising the W/2 and the W/2,
E/2 of Section 15, T-20S, R-37E, N44M, Lea County, New Mexico.

Approval to commingle oil production from the Weir Pool with condensate
production from the Weir-Tubb Gas Pool on the Britt B-15 Lease was granted by
Order No. R-1594. It is requested that this order be amended to also include
oil production from the Monument and oil production from the Weir-Tubb Gas Pools.

In support of this request, the following information, as required by
Rule 303, is advanced:

1. Each pool on the Britt B-15 Lease is provided with a single common
source of supply and the wells therein are completed, cemented, and
operated as so to prevent communication, within the pool, with any other
specific pool or horizon.

2. The gravities, values, and volumes of the oil and condensate
produced on the Britt B-15 Lease are as follows:

3. The expected gravity of the commingled liquid hydrocarbons is 36.9° A.P.I.
4. The expected value of the commingled liquid hydrocarbons is \$871.64.
5. The commingled liquid hydrocarbons will have an average value of \$21.68 more per day than the non-commingled production.
6. Copies of this application have been furnished this date by registered mail to all persons owning any interest of record in the subject acreage.

Attached hereto are a schematic diagram of the proposed installation and plat showing the location of all wells on the Britt B-15 Lease and the pool from which they are producing.

The granting of this application is in the interest of preventing waste and the protection of correlative rights.

In view of the facts set out herein it is respectfully requested that the Commission amend Order No. R-1594 administratively to approve commingling production after separate measurement from the Monument, Weir-Tubb Gas, and Weir Pools on Continental Oil Company's Britt B-15 Lease.

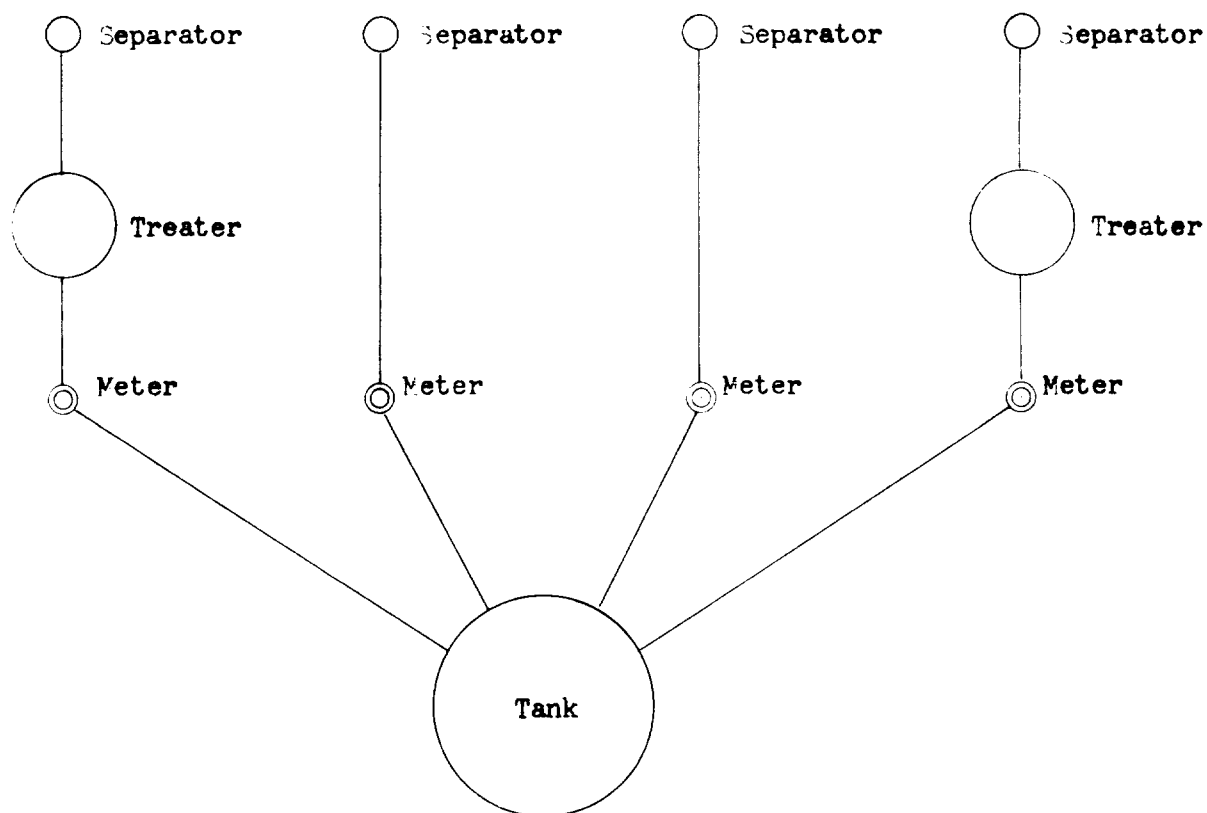

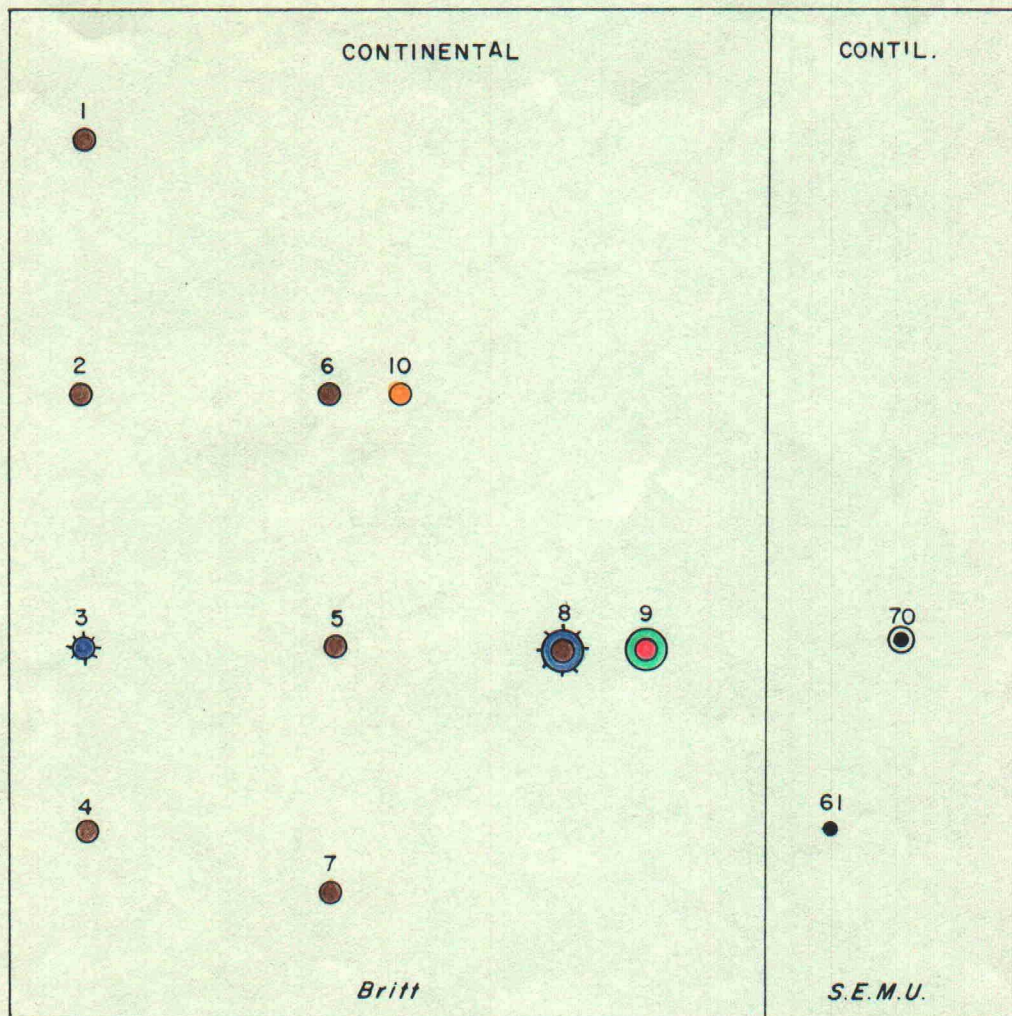


CONTINENTAL OIL COMPANY
