

Ramsay (NCT-B) lease comprising the NW/4, S/2 NE/4 and NE/4 NE/4 of Section 25, 21-S, 36-E and our Graham State (NCT-J) lease, comprising the NW/4 NE/4 of Section 25, 21-S, 36-E after separately metering the production from the Drinkard and Paddock Pools and determining the production from the Penrose Skelly zone by the subtraction method.
