
Further to a recent telephone conversation between your Mr. Nutter and our Mr. Christensen, we are hereby requesting an amendment to the subject order dated January 30, 1961, to permit the use of direct connecting lines from the Abo and the San Andres headers. This order was requested by our letter dated December 30, 1960.

It is proposed that four two-way gas operated motor valves be used to automatically insure that the two zones could not be mixed prior to metering. A drawing of the proposed header and test equipment installation is attached. A three-way three-position gas control valve will be used to open and close the header valves and this control valve would normally be in position No. 1 whereby no gas would be supplied to the two-way motor valves. To test a San Andres well, the gas control valve would be turned to position No. 2 which would open the motor valve on the San Andres header and would also open the valve on the test metering separator back to the San Andres metering separator. To test an Abo well, the gas control valve would be turned to position No. 3 whereby the San Andres header valves would close and the Abo header valves would open. This would insure no mixing of the two zones prior to metering. All four of the header motor valves would be normally closed (fail-safe).

In view of the above, we ask your consideration of our request to amend the subject order to provide for the use of the equipment arrangement shown on the attached drawing.
