
Gentlemen:

Enclosed herewith is "Application for Dual Completion" for the above captioned well on which the operator requests administrative approval. Attached to the application are the required diagrammatic sketch, plat, waivers and electrical log of this well, reflecting that the well will be completed in such a manner as to permit the production of oil from an undesignated Yates Pool and production of oil from the North Shugart-Queen Grayburg Pool through parallel strings of 2-1/16" tubing installed within a string of 5-1/2" casing set at total depth.

The operator also requests permission to commingle the oil in common storage above ground from the separate zones, this request being included in the letters of waiver from the offset operators. The owner interests at all depths are identical in this well.



If, after said twenty-day period, no protest nor request for hearing is received by the Santa Fe office, the application will then be processed.

NOTE: If the proposed dual completion will result in an unorthodox well location and/or a non-standard proration unit in either or both of the producing zones, then separate application for approval of the same should be filed simultaneously with this application.


