to Permit Addition to Commingling
Facilities, TEXACO Inc. A. H.
Blinebry (NCT-1) Leases, Lea County
New Mexico

Gentlemen:

Administrative Order PC-29, dated April 6, 1961, granted TEXACO, Inc. authority to commingle oil production from the Blinebry, Tubb, and Drinkard Pools from all wells completed or drilled on the A. H. Blinebry (NCT-1) Lease comprising the N/2 N/2 and S/2 NW/4 of Section 29, Township 22 South, Range 38 East, NMPM, Lea County, New Mexico, after separately metering the production from each pool. TEXACO, INC. respectfully requests administrative approval to expand to include the S/2 of Section 20, Township 22 South, Range 38 East, which is adjacent to the aforesaid area.

The S/2 of Section 20 is a portion of the A. H. Blinebry (NCT-1) Lease as is the area described in Administrative Order PC-29. TEXACO, Inc. recently dually completed a well in the Blinebry and Tubb pools and plans to drill a single completion in the Blinebry Pool in the near future, both wells being located in Section 20 and indicated on the attached plat. By expanding the commingling area to include the S/2 of Section 20, Tubb and Blinebry production from this area can be routed through metering equipment that is currently in use at the commingling battery in Section 29. Metering facilities at this battery separately and respectively measure production from the Blinebry, Tubb, and Drinkard pools, and adequate testing facilities are installed for determining the producing capacity of each well at least once each month.

Your early consideration of the matter would be appreciated.


