Gentlemen:

Reference is made to your application dated November 3, 1961, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit the commingling of the production from the Denton and Denton Wolfcamp Pools on your Pacific Royalty Lease located in Section 10, Township 15 South, Range 37 East, MHPM, Lea County, New Mexico, without separately metering the production from each pool.
