Gentlemen:

Reference is made to your application dated February 20, 1962, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit the commingling of the oil production from the Wants-Abe Pool and the distillate production from the Tubb Gas and Blinabry Gas Pools on your Roy Barton Lease, located in Section 23, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, without separately metering the production from each pool.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, you are hereby authorized to commingle the oil production from the Wants-Abe Pool and the distillate production from the Tubb Gas and Blinabry Gas Pools on the above-described Roy Barton Lease, without separately metering the production from each pool; provided however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities"; and provided further however, that you shall immediately notify the Commission at such time as any well in the Wants-Abe Pool is capable of top allowable production.
