

Gentlemen:

In accordance with New Mexico Oil Conservation Commission Rule 303-B, Texaco Inc. respectfully requests permission to commingle the liquid hydrocarbon production from the East Weir Tubb with the presently commingled Skaggs Drinkard, Skaggs Glorieta and East Weir Blinebry Pools production on the basis of periodic well testing.

Texaco's C. H. Weir "A" Well No. 11 (East Weir Tubb Zone) was producing into a tank battery which was recently destroyed in a fire caused from an electrical storm. In order to eliminate the necessity of erecting an additional tank battery for the C. H. Weir "A" Well No. 11, Texaco desires to commingle the production with the Skaggs Drinkard, Skaggs Glorieta, and East Weir Blinebry Pools production. The well is incapable of producing top unit allowable as are the wells currently producing into the present commingled battery.


The gravity of the Tubb crude is 48.8° API with a value of \$3.81 per barrel. The gravity of the Skaggs Drinkard, Skaggs Glorieta and East Weir Blinebry is 36.0° API with a value of \$3.62 per barrel. The expected gravity of the commingled liquid hydrocarbon production is 37.0° API with a value of \$3.62 per barrel and no change in the actual commercial value of such commingled production.

A schematic diagram of the proposed commingling installation and plat of the subject lease are attached.

Shell Pipeline Company as purchaser of crude production is being furnished a copy of this application.






Plat of Texaco Inc. C.H. Weir "A" Lease
