Reference is made to your recent application for permission to commingle the production from the Blinbry, Tubb-Drinkard, and Fusselman Pools, North Justis Field, Lea County, New Mexico, underlying your C. C. Fristee (b) MCF-2 Lease located in Section 26 and Section 35, Township 24 South, Range 37 East, Lea County, New Mexico, after separately metering the Tubb-Drinkard and Fusselman production and allocating production to the Blinbry zone by the subtraction method.

Administrative Order PC-96 authorized commingling on the aforesaid lease of production from the Tubb-Drinkard, Devonian, and Fusselman Pools. However, the Devonian has proven non-productive and you wish to substitute the Blinbry Pool in the commingling authority.

Administrative Order PC-96 is hereby amended to include the Blinbry formation and delete the Devonian formation.
