Gentlemen:

Reference is made to your application dated November 16, 1962, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit the commingling of Penrose-Skelly and Paddock production and the commingling of Blinbry and Drinkard production in two separate tank batteries on your State DC Lease comprising the S/2 of the NW/4 of Section 19, Township 21 South, Range 37 East, Lea County, New Mexico, after separately metering the Drinkard production and determining the Blinbry production by means of the subtraction method, and after separately metering the Paddock production and determining the Penrose-Skelly production by means of the subtraction method.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, you are hereby authorized to commingle the production from the aforesaid pools on said lease in the above-described manner. Provided however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," including the requirement for non-reset counters on the meters.
