Re: Application of Amerada Petroleum Corporation for administrative approval of an exception to Rule 303 (a) of the Commission Rules & Regulations, to permit the commingling of the Vacuum Blinebry and the Vacuum Glorieta into a common storage on its State "VB" Lease, described as the NE 1/4 of the SW 1/4, Sec. 36, T17S, R34E, Lea County, New Mexico.

Gentlemen:

Amerada Petroleum Corporation is the owner and operator of the 40 acre State "VB" Lease, described as the NE 1/4 of the SW 1/4, Sec. 36, T17S, R34E, Lea County, New Mexico. Applicant proposes zone commingling of production from the Vacuum Blinebry and the Vacuum Glorieta Pools by the subtraction method as outlined below:


1. The Vacuum Blinebry and Vacuum Glorieta will be commingled into a common sweet crude storage, while the Vacuum Grayburg-San Andres will remain separated into a sour crude battery.
2. The lease will have only one completion in each of the above zones.
3. The daily production will be top allowable from both zones, with the Vacuum Blinebry producing 68 barrels of 34<sup>o</sup> oil per day and the Vacuum Glorieta producing 51 barrels of 39<sup>o</sup> oil per day.
4. The total combined daily production of both zones will be 119 barrels of 37<sup>o</sup> oil with a value of \$351.05. Actual value of the commingled oil well be \$2.01 per day greater than the non-commingled crude.

5. The economic advantage of commingling in the above described manner lies in equipment installation.
6. A plat showing well locations along with a schematic diagram of the proposed installation are attached.
7. The applicant will operate the proposed installation in accordance with provisions of the Commission's "Manual for the Installation and Operation of Commingling Facilities", including the requirement for a non-reset counter on the meter.
8. That approval from the State Commissioner of Public Lands is being obtained and will be furnished as soon as it is received.

Applicant requests that administrative approval be given the above matter at the earliest date possible.




