Dear Sir:

We have been directed by Mr. Joe D. Ramey, Supervisor, District No. 1, to direct this request to your attention.

It is our desire to commingle the production from our Fren Pool Wells with those we have in the Grayburg-Jackson Pool. In the Fren Pool we have four(4) wells, our Foster LC 049998 (a) Well # 2-4-6-8-7. In the Grayburg-Jackson Pool we have two (2) wells, our Foster LC 049998 (a) Well #1 & 3.

Presently we produce our Fren Pool Wells into a Battery consisting of 2-100 Barrel Stock Tanks #84655 and 84656. These wells make approximately 90 barrels of oil per month, all wells. The two Grayburg-Jackson Pool Wells produce into a battery of 2-210 Barrel Stock Tanks #83410 & 83411. These wells make approximately 360 barrels of oil per month, both wells. If our request is granted we propose to produce all of our wells into Tanks #83410 & 83411 and to dismantle our tanks #84655 & 84656. We are attaching drawings of the Lease, Tank Batteries and our proposed Battery.

We were told to explain the manner of testing our wells. If permission is granted to commingle these wells, we plan to take all future test with a portable well testing machine at each individual well rather than through a manifold test at the battery.

We trust that we have furnished you with all the necessary information. If you need anyother information please let us know.





## Proposed Battery




