Dear Mr. Losee:

Reference is made to your application dated September 12, 1963, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit H. R. Denius et al to commingle Corbin-Queen and Maljamar production from the Federal LC 060967 Lease comprising the NW/4 of Section 34, Township 17 South, Range 33 East, Lea County, New Mexico, allocating the production on the basis of periodic well tests. It is our understanding that all of the aforesaid production is of marginal nature.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, H. R. Denius et al is hereby authorized to commingle the production from the aforesaid pools on said lease in the above-described manner. Provided however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities"; and provided further however, that you shall immediately notify the Commission at such time as any well in either pool is capable of top allowable production.
