Gentlemen:

We are, by this letter and enclosed documents making application for an exception to Rule 303(a) of the N.M.O.C.C. Rules and Regulations. We propose to commingle whatever wells we may successfully complete in the Yates Zone with the already commingled (Administrative Order #PC-170) Paddock and San Andres Zones on Shell's State "V" Lease located in E/2, SE/4, Section 27, T-17-S, R-35-E in the Vacuum Field. Since each of these zones contains top allowable wells, we plan to continuously meter and sample the Yates and Paddock Zones as prescribed by the subtraction method of zone commingling. Individual well production will be allocated by monthly well tests which will be conducted by producing the subject well through a metering separator. Since both the Paddock and San Andres are sour with an API gravity range of 35° to 38° and the Yates is normally sour with a similar gravity range, we expect no change in revenue as a result of commingling. Daily production in the San Andres and Paddock Zones is 78 barrels and 69 barrels respectively. Production from each Yates well added is expected to be equal to top allowable for that zone.






SHELL OIL CO.
