Gentlemen:

We are, by this letter and enclosed documents, requesting an amendment to Administrative Order PC-171 which gives Shell Oil Company permission to commingle the Glorieta and San Andres crudes on the State "T" Lease, Vacuum Field, Lea County, New Mexico. Since this order was issued, we have obtained an intermediate market for the Glorieta and propose to commingle it with the intermediate priced Abo crude. Production from the four Abo wells is approximately 9000 barrels of 38° to 40° oil per month. Production from the two Glorieta wells has been approximately 4200 barrels of 37° to 39° oil per month. We anticipated an increase in revenue of from 7¢ to 9¢ per barrel of Glorieta oil as a result of the new market. However, we expect no significant difference in revenue to exist as a result of commingling of the two crudes.

As per the attached schematic, we plan to separately meter and sample the Glorieta production and to determine the Abo production by the subtraction method. Production for individual wells will be allocated by monthly well tests which will be conducted by producing the subject well through a metering separator.

The following attachments accompany this letter 1) Plot of Lease 2) Schematic of Installation 3) Letter of Approval from State Land Department.


In view of the above presented information, we respectfully request your approval of this project which we feel is in the best interests of both the State of New Mexico and Shell Oil Company.



1"=2000'


SHELL OIL CO.
