Gentlemen:

Reference is made to your application dated June 2, 1964, as amended by your letter of June 23, 1964, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit the commingling of North Vacuum Abo, Vacuum Wolfcamp, Vacuum Upper Pennsylvanian, and Vacuum Devonian production on your State "CC" Unit comprising the N/2 of the SW/4 of Section 36, Township 17 South, Range 34 East, Lea County, New Mexico, after separately metering the production from each pool.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, you are hereby authorized to commingle the production from the aforesaid pools on said lease in the above-described manner. Provided however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," and provided further, that you shall notify the Commission at such time as the installation is complete in order that a field inspection may be made of the installation prior to putting it in operation.

Gentlemen:

Reference is made to your letter of June 2, 1964, in which you have requested approval to commingle production in the VACUUM ABO NORTH, VACUUM WOLFCAMP, VACUUM UPPER PENNSYLVANIAN and VACUUM DEVONIAN Pools in the subject lease.

Please be advised that Mobil Oil Company may proceed with this commingling project, with the approval of the New Mexico State Land Office. Upon completion of the installation of the common tankage equipment and accessories, but before they are put into operation, we should like to request that Mobil notify this office of the completion, so that an inspection of the installed equipment might be accomplished. This approval is contingent upon the condition that the Oil and Gas Division shall be notified of any changes or alteration in the system design, and that the Commissioner of Public Lands reserves the right to review this decision if and when commingling appears to reduce the royalty due to the State of New Mexico.
