Mobil Producing Texas and New Mexico, Inc. respectfully requests permission to amend Administrative Order PC-252 to permit the surface commingling of the Wantz-Abo production on the D. A. Williamson lease with the currently commingled Blinebry and Drinkard production on this lease. The D. A. Williamson lease comprises the NE/4 of Section 23, Township 23 - South, Range 37 East, Lea County, New Mexico. Ownership is common.

The commingled production will consist of approximately 140 barrels of oil per day (38.5° API) from the Wantz-Abo and 2 barrels of oil per day (36.9° API) from the commingled Blinebry and Drinkard. There will be no loss in commercial value by commingling the three zones. In fact, the commercial value should increase slightly as 2 bbls at 36.9° will be commingled with 100 + bbls. of 38.5° crude. This should result in all commingled crude with a 38° API gty. Please find the enclosed schematic of the proposed installation and plat of the lease. Production will be allocated on monthly well tests.




