**Request for Administrative Amendment of
Commingling Order PC-256 To Authorize the
Surface Commingling of Paddock Production from
the Lockhart A-27 Well #14 with the Currently
Approved Commingled Blinebry, Tubb, Drinkard,
Abo, and Paddock Production from the same Lease**

Dear Mr. LeMay:

Commingling Order PC-256 (copy attached), issued April 11, 1991, approved the commingling of Blinebry, Tubb, Drinkard, Abo, and Paddock production from the Lockhart A-27 Lease in a common tank battery. This order assumed that interests were common in all zones and that allocation would be determined by well tests.

Since this order was issued, Well #14 of this same lease, has been recompleted to the Paddock Pool. However, one of the working interest owners went non-consent in the recompletion of well #14, which created a interest formula that is not common with the other wells and pools on the lease. Therefore, Well #14 has been provided with its own metering vessel, which is documented on the attached updated facility diagram.

Since detailed data has already been submitted, and approval granted for commingling of these various pools, it is assumed that the only additional approval for Well #14 would be the addition of a requirement for separate metering before commingling of this one well. It is requested that this amendment to the original order be granted to properly handle this well with different interests.
