Gentlemen:

Reference is made to your application dated June 24, 1965, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit the commingling of Basin Dakota distillate and Tocito Gallup oil from your Jicarilla A Well No. 2 located in Unit B, Section 18, Township 26 North, Range 5 West, Rio Arriba County, New Mexico, allocating the production to each well on the basis of periodic tests.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, you are hereby authorized to commingle the production from the aforesaid pools on said lease in the above-described manner. Provided, however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," and provided further, that you shall notify the Commission at such time as the Tocito Gallup zone becomes capable of top allowable production.
