Gentlemen:

We hereby request an exception to Rule 303 (a) and administrative approval to commingle the production from the Tenneco Ginsberg Federal Lease, located in Sec. 31, T25S, R38E, Lea County, New Mexico, as follows:

1. Commingle production from well Numbers 5,6,7 & 8 in the Langlie Mattix Pool with well Numbers 8,9,10 & 11 in the Justis Blinebry Pool. These Langlie Mattix wells produce 12 barrels of 34.4 gravity sour crude per day with a value of \$2.77 per barrel. These Justis Blinebry wells produce 105 barrels of 35.4 gravity sour crude per day with a value of \$2.80 per barrel. The commingled production is expected to be 117 barrels with a gravity of 35.3 and value of \$2.80 per barrel.

2. Commingle production from well numbers 9 & 11 in Justis Fusselman Pool with well Number 11 in Justis Tubb Pool. These wells in Justis Fusselman produce 70 barrels of 36.4 gravity sweet crude per day with a value of \$2.93 per barrel. The Justis Tubb well produces 11 barrels of 36.3 gravity sweet crude per day with a value of \$2.93 per barrel. The commingled production is expected to be 81 barrels of 36.4 gravity sweet crude with a value of \$2.93 per barrel.

In each case the value of the commingled production is not less than the sum of the values of the production from each common source of supply.

The ownership of all zones is identical and all of the wells are incapable of producing top limit allowable.

A copy of this application is being furnished to the Regional Supervisor of the United States Geological Survey, with a request for their approval of the installation.

Facilities will be installed to test the production from each well and from each pool periodically as the Commission may prescribe.

To support this request, the following are attached:

1. Tabulation of production for a 60-day period.
2. Schematic diagram of the proposed installation.



