Gentlemen:

In accordance with New Mexico Oil Conservation Commission Rule 303(b) TEXACO Inc. hereby makes application for administrative approval of an exception to Rule 303(a) to permit commingling operation to be conducted on the G. L. Erwin "b" NCT-1 Lease, Langlie-Mattix and Justis (Blinebry) Pools, Lea County, New Mexico. It is proposed that the liquid hydrocarbon production from the Justis (Blinebry) be metered and that the production from the Langlie-Mattix be determined by the subtraction method.

The G. L. Erwin "b" NCT-1 Lease contains 160 acres being the NE/4 of Section 26, T-24-S, R-37E. Attached is a plat showing the location of all wells and the pools from which they are producing. This lease currently has six wells, four completed in the Langlie-Mattix Pool, two completed and one drilling in the Justis (Blinebry) Pool.

The expected daily liquid hydrocarbon production from the Justis (Blinebry) Pool is 70 barrels of 37.4° API gravity oil at \$2.94/bbl and that from the Langlie-Mattix Pool is nine (9) barrels of 36.8° API gravity oil at \$2.92/bbl. The combined daily production after commingling is expected to be 79 barrels of 37.3° API gravity oil at \$2.94/bbl; resulting in a gain in revenue of \$0.18 per day. The production from the zones to be commingled is considered as sour.


Royalty Interest in the subject lease is common and is held in part by the U. S. Federal Government and a copy of this application is being sent this date to the U. S. Geological Survey, Roswell, New Mexico, requesting their approval in writing of the proposed installation. Immediately upon receipt of this approval, it will be forwarded to the Commission.

Texas-New Mexico Pipe Line Company is the purchaser of the crude from the battery serving the Langlie-Mattix zone, which will become the commingled battery, therefore, Texas-New Mexico Pipe Line Company is also being notified by copy of this application and their consent in writing to take the commingled crude will be requested.

A schematic diagram of the proposed commingling is attached. The proposed commingling is in accordance with Item II, Section 2-B of the current "Manual for the Installation and Operation of Commingling Facilities".

In view of the above facts it is respectfully requested that administrative approval of an exception to Rule 303(a) be granted TEXACO Inc. to permit commingling into a common tank battery production from the Justis (Blinbry) and Langlie-Mattix Pools on the G. L. Erwin "b" NCT-1 Lease and from all wells which may be completed in these reservoirs on this lease in the future.




LEGEND
