**Administrative Order PC-324**

**Gentlemen:**

Reference is made to your letter dated March 8, 1968, wherein you advise that the application for commingling was in error for several of the wells covered by Administrative Order PC-324. This order authorized the commingling of Dakota and Mesaverde condensate production from certain wells in Rio Arriba County, New Mexico.

Administrative Order PC-324 is hereby amended to authorize the commingling of condensate from the Basin-Dakota and Tapacito-Gallup Pools from the following wells in Township 26 North, Range 5 West, Rio Arriba County, New Mexico:

Jicarilla "A" Well No. 3 - Unit A of Section 19  
Jicarilla "A" Well No. 5 - Unit G of Section 20  
Jicarilla "B" Well No. 4 - Unit H of Section 21  
Jicarilla "C" Well No. 3 - Unit I of Section 23

Administrative Order PC-324 in all other respects remains in full force and effect.
