

Amerada Petroleum Corporation is owner and operator of the J. G. Hare lease described as the SW/4 of Section 33, T-21-S, R-37-E, Lea County, New Mexico. The J. G. Hare No. 5 is a Blinbry gas well and produces 22.8 barrels of 48 gravity condensate per million cubic feet of gas. The J. G. Hare No. 7 is a well and produces 5.3 barrels of 61 gravity condensate per million cubic feet of gas. Neither well produces water. Each well produces into separate storage facilities at present.

Amerada requests administrative approval to commingle the produced fluids. It is proposed that the condensate production be allocated to the individual wells based on well tests. The production facilities will be used for well tests with one well closed in. No change in income is anticipated due to commingling.




