Gentlemen:

In accordance with Rule 303 application is hereby made on behalf of Guy R. Zachry for administrative approval to commingle production from the Paddock and Drinkard pools from the Grizzell lease, comprising the N/2 NE/4 Section 8, Township 22 South, Range 37 East.

Drinkard Pool: production obtained from Grizzell No. 3, located 750' from North line and 760' from East line of Section 8, daily average production 2 to 4 barrels per day, average gravity 33°, average price \$2.86 per barrel. Grizzell No. 1, located 660' from North line and 1980' from East line of Section 8 has been shut in since March 1962.

Paddock Pool: production obtained from Grizzell No. 2 located 660' from North line and 660' from East line of Section 8, daily average production 16 to 20 barrels per day, average gravity 36°, average price \$2.92 per barrel.

Interest Owners: identical interest throughout entire 80 acres with no differentiation as to pools or location.

Commercial Value: estimated value of commingled production to be \$2.91 per barrel, and will not be less than the sum of the values of production prior to commingling.

Method of Allocation: allocation of production to be based on periodical gas-oil ratio tests. No special testing facilities necessary as one well will be shut in while other well is on test.

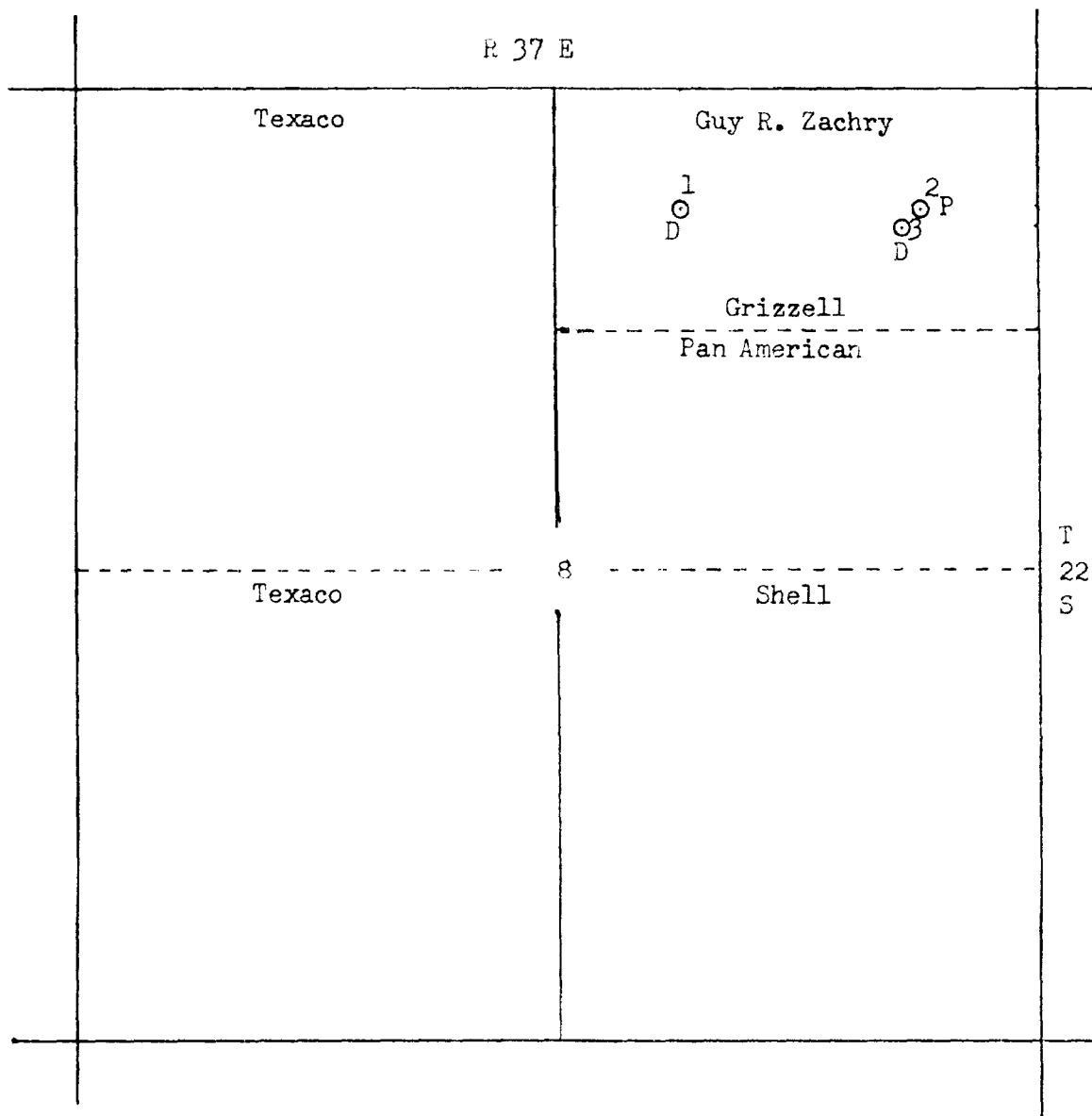
