Gentlemen:


The subject well is dually completed in the Lightcap Devonian and Pennsylvanian pools. Mobil Oil Corporation respectfully requests administrative approval to commingle, on the surface of the ground, production from this well in common facilities. Approval is also requested to use the subtraction method to account for production. A meter and sampler will be installed to measure the Penn production.

The following documents are submitted in triplicate supporting this request:

1. Exhibit #1 - Schematic diagram of the proposed commingling installation.
2. Exhibit #2 - Data concerning gravity, volume and value of the crude.
3. Exhibit #3 - Plat of the Lightcap Field and surrounding area.
4. Exhibit #4 - Letter from purchaser of the crude stating that he has no objection to continue taking the commingled production.




Dear Mr. Glendinning:
