P Reference is made to your request for the amendment of Administrative Order PC-378 which authorizes the commingling of South Hospah Upper Sand and South Hospah Lower Sand production from certain wells on your Santa Fe "A" Lease in Section 1, Township 17 North, Range 9 West, Hospah Field, McKinley County, New Mexico, allocating the production on the basis of periodic well tests. It is our understanding that certain other wells have now been completed in the aforesaid two pools and you wish to include them in the commingling authority.

Y Administrative Order PC-378 is hereby amended to authorize the commingling of South Hospah Lower Sand production and South Hospah Upper Sand production from all wells completed on your Santa Fe "A" Lease, allocating on the basis of periodic well tests. Provided however, that you shall notify the Commission at such time as any well in either pool is capable of top allowable production.
