Re: Request for Administrative Approval to Commingle Oil Production from the San Andres - Grayburg, Blinebry, and Drinkard Zones in the Hobbs Pool on the Getty Oil Company H. D. McKinley Lease, Sec. 30, T-18-S, R-38-E, Lea County, New Mexico.

Gentlemen:

Getty Oil Company requests administrative approval to commingle oil production from the Hobbs San Andres - Grayburg, Blinebry and Drinkard Pools on its H. D. McKinley Lease in accordance with N.M.O.C.C Rule 303 (b), 2-B.

In support of this application, the following information is attached.

1. Table I - Gravity and Sales Value data for the Crude Production.
2. A schematic diagram of the proposed commingling facilities.
3. A plat of the H. D. McKinley Lease showing the location of the wells and the pools from which each well is producing.

In addition the following information is submitted:

1. The N.M.O.C.C. by Administrative Order PC-384 dated July 28, 1969 authorized commingling of the Hobbs San Andres - Grayburg and Blinebry Pools on the Getty H. D. McKinley Lease.
2. Royalty and working interest ownership is common for all pools.
3. It is proposed to meter the Blinebry and Drinkard oil production.
4. To determine the BS&W content, the oil production will be sampled prior to commingling.
5. The San Andres - Grayburg production is to be determined by the Subtraction Method as outlined in the M.M.O.C.C. Manual for the Installation and Operation of Commingling Facilities."

6. Presently four (4) San Andres - Grayburg, two (2) Blinebry and one(1) Drinkard producers are on the lease. Depending upon the development of the Blinebry and Drinkard reservoirs, there may ultimately be four (4) Blinebry and two (2) Drinkard completions on this lease.



 Flow Diagram of Proposed Comminling Facilities


