Re: Application to Ammend the Commingling Provisions of Administrative Order PC-387 Dated November 12, 1969 to Permit Removal of the Drinkard Metering Equipment on The Getty Oil Company H. D. Mc Kinley Lease, Hobbs Grayburg-San Andres, Blinebry, and Drinkard Pools, Lea County, New Mexico.

Gentlemen:

Getty Oil Company respectfully requests permission to remove the meter from the Drinkard Zone and to commingle the Blinebry and Drinkard, allocating production by well test. Thence, metering the combined Blinebry and DRinkard production before commingling with the Grayburg-San Andres production. The Grayburg-San Andres production shall be determined by the subtraction method.

In support of this Application the following information is attached:

1. Table I - Gravity and Sales Value Data for the crude production showing the Blinebry and Drinkard production to be marginal.
2. A schematic diagram of the proposed commingling facilities.
3. A plat of the H. D. Mc Kinley Lease showing the location of the wells and the pools from which each well is producing.

In addition the following information is submitted:

1. The N.M.O.C.C. by Administrative Order PC-387 dated November 12, 1969 authorized commingling the Hobbs Grayburg-San Andres, Blinebry and Drinkard Pools on the Getty H. D. Mc Kinley Lease after metering each zone separately.
2. It is proposed to meter the combined Blinebry and Drinkard oil production and to obtain the Grayburg-San Andres production by the subtraction method as outlined in the N.M.O.C.C. "Manual for the Installation and Operation of Commingling Facilities".
3. It is proposed to allocate the Blinebry and Drinkard production by well test, since each of the wells in these zones are marginal.

4. Royalty and Working Interest ownership is common from all pools.
5. Presently five (5) Grayburg, Three (3) Blinebry and one (1) Drinkard producers are on the lease.




