An exception to Administrative Order PC-393 (copy attached) is hereby requested to allocate the production from each pool on the basis of monthly well tests as opposed to separately metering each pool's production.

We propose to install a three phase treater to obtain accurate well tests on a monthly basis. This will eliminate one-two phase separator and the need to "truck treat" the produced fluids prior to sales, thus providing a more efficient operation.

Administrative Order PC-393, dated November 19, 1969, granted Amoco approval to surface commingle production from the Hobbs Drinkard, Hobbs Blinebry, and Hobbs Grayburg San Andres on the State "G" Lease. Currently, only the Drinkard and Blinebry pools are producing. The Grayburg San Andres is no longer active. Ownership of the pools is common.



ENGINEERING CHART


SUBJECT STATE G. LEASE - BLINEBRY - DRINKARD COMMINGLE



REQUEST. APPROVAL TO COMMINGLE BLINEBRY & DRINKARD WELLS ON THE STATE G. LEASE PRIOR TO METERING PRODUCTION.

PURPOSE. - TO ELIMINATE THE NEED FOR TRUCK TREATING PRODUCTION PRIOR TO SALES, ELIMINATE TRUCK DISPOSAL OF PRODUCED WATER, AND TO ADD MORE ACCURATE TESTING EQUIP. AND MAKE A MORE EFFICIENT OPERATION.

METHOD. - ELIMINATE (1) ONE 2 PHASE SEPERATOR
 INSTALL UPSTREAM LEASE TEST HEADER
 INSTALL 3 PHASE TEST METERING TREATER FOR ACCURATE METERING OF OIL, WATER & GAS ON REGULAR SCHEDULE. AND ELIMINATE NEED TO USE TRUCKS TO SEPERATE OIL & WATER.


