Gentlemen:

This is a request to amend Order No. R-1905 and Administrative Order PC-394 to provide for the addition of the Grizzell "B" Well No. 3 Fusselman oil production to be commingled with Paddock and Blinebry production in our Grizzell "B" Battery. The Battery is located in Unit G SW/4 NE/4 Section 8, T-22-S, R-37-E. The commingling of Paddock and Blinebry production on our Grizzell "B" Lease was approved by Order No. R-1905 and amended by Administrative Order PC-394. A schematic of the facility and a plat depicting the lease and wells involved are attached.

Our Grizzell "B" Well No. 3, located 1830' FNL & 510' FEL, Section 8, T-22-S, R-37-E, Lea County, New Mexico, was completed on November 19, 1979 as a flowing oil well in the Wildcat Fussleman Oil Pool and commenced production on that day.

Oil from the Grizzell "B" Well No. 3 will be separately metered and sampled, and the installation shall be in accordance with the "Manual for the Installation and Operation of Commingling Facilities". Production from the Paddock and Blinebry will be allocated based on well tests as previously approved. The gas production is metered and sold separately and will not be commingled.






Gentlemen:

Reference is made to our letter dated February 2, 1970, File: VES-59-400, on the above subject, concerning Administrative Order PC-394, dated January 26, 1970.
