The above-named company is hereby authorized to commingle production from the following pools

Blinebry Oil, Blinebry Gas, Tubb Gas, and Drinkard

in a common tank battery, and to determine the production from each pool by

_____ separately metering the production from each pool prior to commingling

_____ separately metering the production from *the Blinebry Gas Pool and the ~~Bl~~ Tubb Gas Pool* and determining the *Blinebry Oil Pool and Drinkard Pool* production by the subtraction method

_____ well tests (if this method is to be authorized, all commingled production must be of marginal nature; further, the operator shall notify the Santa Fe Office of the Commission in the event any well producing into the commingled battery becomes capable of top allowable production, at which time the Commission will amend this order or take such other action as may be appropriate)

Note: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Commission Rules and Regulations and the Commission "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: *Administrative Order PC-406, prior to this amendment, authorized commingling of Drinkard and Blinebry oil production and Tubb condensate production only.*

Dear Sir:

It is respectfully requested that Administrative approval be given to adding Blinebry condensate to the commingling authority previously granted for Blinebry and Drinkard oil and Tubbs condensate. (Administrative Order PC-406, October 26, 1970 and its Amendment November 6, 1970).


Sun proposes to allocate production from the Blinebry and Drinkard oil pools on the basis of monthly well tests and to separately meter the Tubbs condensate prior to commingling, as previously approved, and to meter separately condensate from the Blinebry gas pool prior to commingling.

This request is made necessary by the recent reclassification of the State Land "15", well No. 3 from Blinebry oil to Blinebry gas. Application for approval of a proration unit for this well has been previously submitted to the New Mexico Oil Conservation Committee in Santa Fe.

There will be no appreciable change (less than 1° API) as a result of commingling as outlined in this request.
